

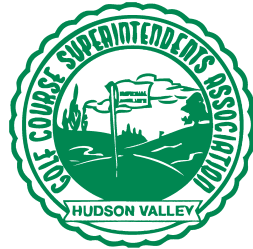
Dear Friend,
